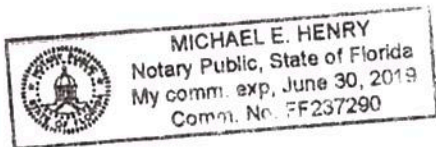

NOTICE IS HEREBY GIVEN that the Board of Directors of the Sebring Airport Authority ("SAA") will hold regular Board Meetings on the third Thursday of each month for the year 2018. Meetings will be held at 1:00 p.m. in the Hendricks Field Center of the Air-side Center located at 128 Authority Lane, Sebring, Florida. The Board of Directors of the Sebring Regional Airport and Industrial Park Community Redevelopment Agency ("CRA") will hold regular Board Meetings that will follow immediately after each of the SAA Board Meetings. Any person may appear and be heard with respect to the issues raised during these meetings.

Pursuant to Section 286.0105 of the Florida Statutes, as amended, both SAA and CRA hereby advise that if any interested person decides to appeal any decision made by those boards with respect to any matter considered at the proceedings, he or she will need a record of the proceeding and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. SAA and CRA also give notice that the Chairman of the Boards is authorized to cancel or postpone any scheduled meeting by directing the Executive Director to so inform all Board Members, the press, and any other necessary parties.
